- **CPT (Carriage Paid To) - Named Destination NA – Incoterms® 2020 Rules:**
Whereby UAM's obligation ceases upon Loading of USA Inland Carrier, as nominated by UAM, NA Inland Carrier Delivery, Un-Loaded with Freight Cost Pre-Paid, to Purchaser's Consignee, or Purchaser's Freight Forwarder Agent, at Named Destination NA.
- **CIP (Carriage and Insurance Paid To) – Named Destination NA – Incoterms® 2020 Rules:**
Whereby UAM's obligation ceases upon Loading of USA Inland Carrier, as nominated by UAM, NA Inland Carrier Delivery, Un-Loaded with Freight and Insurance Cost Pre-Paid, to Purchaser's Consignee or Purchaser's Freight Forwarder Agent, at Named Destination NA.

- **CFR (Cost and Freight) – Named Port of Destination – Incoterms® 2020 Rules:**
Whereby UAM's obligation ceases upon Loading of USA Inland Carrier, as nominated by UAM, USA Inland Carrier Delivery and Loading of Sea Vessel at Named Port of Departure USA with Ocean Freight Cost Pre-Paid, to Named Port of Destination.
- **CIF (Cost, Insurance and Freight) – Named Port of Destination – Incoterms® 2020 Rules:**
Whereby UAM's obligation ceases upon Loading of USA Inland Carrier, as nominated by UAM, USA Inland Carrier Delivery and Loading of Sea Vessel at Named Port of Departure USA with Ocean Freight and Insurance Cost Pre-Paid, to Named Port of Destination.
